The Cabinet makes the following Regulations under Section 136(i) of the *Electoral Act 2016*:

1 Citation

These Regulations may be cited as the *Electoral (Amendment of Schedules 2 and 3) Regulations 2025*.

2 Commencement

These Regulations commence on the date they are notified in the Gazette.

3 Amendment of the Schedules 2 and 3 of the Electoral Act 2016

Schedules 2 and 3 of the *Electoral Act 2016* are amended by the provisions of these Regulations.

4 Amendment of Form 2 of Schedule 2
