These Regulations may be cited as the *Private Security (Forms and Fees) (Amendment) Regulations* 2025.

2 Commencement

These Regulations commence on the date they are notified in the Gazette.

3 Amendment of the Private Security (Forms and Fees) Regulations 2019

The Private Security (Forms and Fees) Regulations 2019 is amended by these Regulations.

4 Insertion of new Regulation 7A

Regulation 7A is inserted after Regulation 7:

'7A Application for restoration of business licence

For the purpose of Section 22A of the Act, the application for the restoration of a security licence is in Form 6 of Schedule 1.'.
