**CONSERVATION AND MANAGEMENT MEASURES APPLICABLE TO NAURU'S EXCLUSIVE
ECONOMIC ZONES & NAURU FLAG FISHING VESSELS**

Notice by the Minister pursuant to Section 24 of the *Fisheries Management Act 2024*. The Schedule of Conservation and Management Measures (CMMs) adopted by the Western and Central Pacific Fisheries Commission (WCPFC) is hereby publish in the following Schedule. The CMMs adopted by the WCPFC shall apply to Nauru's Exclusive Economic Zone and all fishing vessels flagged to Nauru and operating in waters outside of Nauru's Fisheries waters.

In the event any WCPFC CMM as listed herein is updated, amended or revised by a further CMM, the provisions of such further CMM shall be immediately published under a further Notice.
