

**Twenty-first Sitting of the Eighth Meeting  
Wednesday, 9th June 2004**

**Mr. Speaker, Hon. David Adeang, M.P., took the Chair and read Prayers.**

**Mr. Speaker:** Are there any messages from the President?

**Mr. Speaker:** Are there any notices of motions?

**Mr. Kun (Minister for Justice-Ubenide):** Tubwa, Mr. Speaker.

I wish to raise a matter of privilege as per the statement from the Chair naming me that I made disparaging remarks against your good office and belittled the dignity of this House.

Mr. Speaker, as a Nauruan, I have every right to freedom of expression under Article 12 of the Constitution and cannot be hindered in this enjoyment of that right.

The ABC Radio and Sean Dorney sought information from the Government confirming the technicality and legality of the sitting of Parliament and the tabling of legislations that did not come from Government.

Mr. Speaker, as the Minister for Justice and Attorney General of this Government, I had every right and authority to respond to the situation on behalf of the Government. Mr. Speaker, I believe I have done no wrong in this House. Thank you.

**Mr. Speaker:** Members, ateng konga gamie bwe mwa nim oiya me edae eken bwe anim redodu ine engo bwe anim aea murane won privilege complaint amune Minister for Justice. Anim aea tsinia tsimine won prima facie me anim refer ei ea Privileges Committee oa ekeow.

**Mr. Ribauw (Ubenide):** Tubwa, Mr. Speaker.

I rise on a point of clarification, mangada. Ngune bitune privilege amune Minister totu ian obweta ngage, is it the right time to bring it up? Is this the first opportunity ei gona bring up ei oa dogin bwe aeo tsiet, ang epo ngago nene, I think you made the remarks in the morning, ang break me ang epon ngaga emero. I thought he had time then to bring it up. Wo gona oa iok buogo ine bwe animen ngago enim at the first opportunity eimwi bwe enim riringin, suddenly arising, oa eken. To me, I think too late ngea won min.

Ngea ion wanga point, Mr. Speaker, is he pre-empting the business of the House this morning. A notice of motion was put in yesterday, ample time bed ngea atsin ngago nene ea

ngage from the morning session to the evening session, me a eo teng oturaiy ngago oreit totu won min bwe breach of privilege me anim aea ngago, me a concern ia eimwi kor daein an totu ngune won min. Tubwa.

**Mr. Speaker:** I will take it on advice ngune am kamarar Member for Ubenide. Ang nan break egitow me tsinia ang redo anan pana gamie aeo kamarar ean bitune won amune Minister for Justice complaint.

### **Suspension Resumed.**

**Mr. Speaker:** Honourable Members, ita kor anim pana gamie bitune wanga ruling ean bita won complaint amea Minister for Justice. I have given careful consideration to the complaint of breach of privilege raised by Hon. Russell Kun, and find no prima facie case to be referred to the parliamentary Committee of Privileges. Let me also say that in my view the Member has failed to raise his complaint at the earliest opportunity being immediately after Prayers.

If the Honourable Member disagrees with the Chair's findings he may, of course, seek alternative recourse. Thank you.

**Dr. Keke (Yaren):** Mr. Speaker, ang tik ean notices of motions?

Mr. Speaker, I give notice that at the next sitting, I shall move a motion in accordance with Article 24, being a vote of no confidence in the Government.

**Mr. Speaker:** Seconded by the Member for Ubenide, Mr. Ribauw.

**Mr. Ribauw (Ubenide):** Tubwa, Mr. Speaker.

**Mr. Scotty (Anabar/Ijuw/Anibare):** Mr. Speaker, anga bed me ateng bed question me animen bed tsimine engame teng question ine. Tsitabo aeo dorer amea honourable gentleman from Ubenide, ma teng question, me anga ita megen ian tubu imiton me eiki ia enim name ei ura amebune edogor me ita dogin eow ean ata onano eoran, kaia dogin ata name ei engame ion eo gona ata raquo, me tsinia ouga ebwakura ngabuna enim name ei ura kaia ang nan tik onanon eat edae raquo.

Ogen anan babiyi wanga paid goto ian obwen aeo name ei ura me ouge anga bwe irresponsible aura makur, me oiyamet ekamarar ion ngana nungi ia ama ngabuna rat government me ura ngabuna rat opposition, bwe ngea earura ngaga ia aea ro boycott ei Parliament. ### **Ministerial Statements & Tabling of Papers**

**Mr. Waqa (Boe):** Mr. Speaker, tsimine wanga paper as Chairman of the Committee of

Privileges, me anan retsinei.

Honourable Speaker and Honourable Members, the Committee of Privileges has received a complaint of alleged breach of privilege and contempt of the House from the Hon. Speaker yesterday. The forwarding letter states, and I quote-

*“Dear Chairman,*

*RE - Privilege Matter Raised by Hon. Fabian Ribauw, M.P.*

*Please find enclosed herewith the complaint of breach of privilege and contempt of the House raised by Hon. Fabian Ribauw at the sitting of the Parliament held on 1st June 2004. As I had assured this august House on even date that the complaint has a prima facie case of breach of privilege, I now, therefore refer it to the Committee of Privileges for formal inquest.*

*Yours sincerely (signed) Hon. David Adeang, M.P., Speaker”*

The letter of Hon. Fabian Ribauw forwarded to the Speaker states as follows, and I quote

*“Honourable Speaker,*

*RE - Matter of Breach of Privilege*

*I write to you formally in the matter of breach of privilege and contempt of the House emanating from the non-compliance of the resolution of the House passed at its sitting held on 21st May 2004. The matter was raised by me at the sitting held on 1st June 2004 and Hon. Speaker had ruled that matter of privilege constitutes to be prima facie a case of breach and would be referred by you to the Committee of Privileges.*

*Hon. Speaker may recall that the Parliament on 21st May 2004 inter alia resolved to exonerate all Nauruans involved in the public demonstrations of 22nd and 23rd April 2004. This resolution was never complied by the government and instead a correspondence was received from the Acting Secretary for Justice that the matter had been referred to the substantive Secretary for Justice in Melbourne.*

*Hon. Speaker, the government undoubtedly failed to act on the resolution within the time-frame, i.e. seven days from the passage of the resolution and stands in breach. I therefore request you to refer this matter to the Committee of Privileges for examination.*

*With kind regards. Yours sincerely, (signed) Hon. Fabian Ribauw, M.P.”*

Mr. Speaker, the Committee will commence its examination of the subject at the earliest and I can assure this august House that it will bring in objective report to the Parliament. If any Members found as “interested Members” sitting in the Committee, I can assure they will exclude themselves from the sittings of the Committee.

Thank you very much, Mr. Speaker.”

**Mr. Speaker:** Any further ministerial statements or papers for presentation?

**Mr. Speaker:** Motions 2, 3, 4, and 5 will remain on the notice paper.

**Mr. Stephen (Ewa/Anetan):** Tubwa, Mr. Speaker.

I move that motion No. 6 be deferred to the next sitting and be made an order of the day.

**Mr. Speaker:** At the request of the Member, motion No. 6 will remain on the notice paper.

Any further motions?

**Dr. Keke (Yaren):** Tubwa Mr. Speaker.

“**Recognising** the desirability of a thorough review of the Constitution of the Republic of Nauru given the lack of amendment and update since inception, and to synchronise with modern day requirements and the new situations that have arisen over the last 36 years of Independence, I hereby accordingly move -

That a parliamentary Select Committee be established to examine and review the Constitution of the Republic of Nauru and to make recommendations to the House for amending the Constitution of Nauru as it deems fit;

That the Select Committee shall be named the “Constitutional Review Committee;”

That the Committee shall consist of seven members, namely -

Hon. Baron Waqa

Hon. Fabian Ribauw

Hon. Vinson Detenamo

Hon. Terangi Adam

Hon. Godfrey Thoma

Hon. Riddel Akua

and myself as mover of this motion;

That the quorum of the Committee be five;

That the Committee elect one of its members to be the Chairman, and another member as Deputy Chairman;

That in the event of equality of voting, the Chairman has a casting vote;

That the Committee be provided with all necessary staff, facilities and resources to achieve its objective;

That the parliamentary Legal Counsel, or other person acting in such capacity, be a non-voting Secretary to the Committee (ex-officio);

That the Committee shall have power to send for and examine persons, papers and records, to move from place to place and to meet in public or in private sessions;

That in view of the task and scale of operations, the Committee shall have the power to seek assistance from other departments/individuals, in particular but not limited to the Parliament Secretariat, Chief Secretary's Department and the Department of Justice, in preparing -

- (i) material for inquiry, depositions, hearings, submissions, etc. and
- (ii) the draft Committee report;

That the terms and reference of the Committee shall be as follows-

1. To examine, inquire and report to Parliament by way of recommendations, amendments to be carried out in the Constitution of Nauru as a whole including inter alia Part I, Part II, Parts III and IV vis-a-vis the Articles of the Constitution and the six Schedules thereto;

2. That such amendments, if required, may be looked into for probing and report on the request of the Cabinet, the Chief Justice, Members of Parliament, members of the public or upon experts' opinions/recommendations, at the discretion of the Committee;

3. That such examination and inquiry into such amendments shall include the dissemination of information by the Committee to the Nauruan public, in such manner as determined by the Committee, and sifting of the feed-back received thereon.

4. To achieve these objectives, the Committee may -

(i) appoint a Convention of persons representing the Nauruan community, taking into consideration age and gender balance, who are familiar with the Constitution, its purpose and its effects, and/or the law, and/or with parliamentary experience, to further examine, inquire and report on amendments as instructed by the Committee;

(ii) call for oral and/or written submissions from interested parties for consideration;

(iii) seek advice from constitutional and legal expert(s) in examining, recommending and drafting of the proposed amendments to the Constitution;

(iv) hold public meetings for the purpose of disseminating information to the public and receiving feed-back thereto.

5. To look into and report on all related and consequential matters that may arise subsequent to the proposed amendments such as the impact on, relation to and/or required amendments in various statutes, rules and regulations.

6. To inquire and make recommendations for incorporating new Part(s) or Article(s) to the Constitution for safeguarding the interests of the citizens, improvements in the system and the general welfare of the people, and/or for the repeal of any existing Part(s)/Article(s).

7. To undertake a comparative analysis of the Constitutions of other democratic countries, especially those of the Pacific region, for any possible applications to the Nauru setting.

8. That the report and recommendations will detail the procedures/rules/mandatory provisions to be adhered to for adoption and enactment of any proposed recommendation(s).

That the Committee shall present its report and recommendation(s) to Parliament within nine months of passing of this motion;

That an extension of time for presentation of its report and recommendation(s) may be

granted by appropriate motion approved in the House;

That upon adoption of the report by the House, the Chairman of the Committee shall be required to put all such amendments on notice in the form of a Constitutional (Amendment) Bill, in accordance with the required procedures;

That the foregoing provisions of this motion, in so far as they are inconsistent with the Standing Orders, have effect, notwithstanding anything contained in the Standing Orders.

Thank you Mr. Speaker.

**Mr. Ribauw (Ubenide):** Anga second ei bita motion.

And taking note of the fact that his statement also casts reflections on the impartiality of the Chair;

This House resolves that the Minister for Justice, Hon. Russell Kun, be suspended from the sittings of the House until such time that the Speaker is satisfied with the Minister’s apologies to the Office of the Speaker, and also to the House through the Speaker, together with pledges from the Minister to give effect to Acts and resolutions of Parliament agreed to on 20th and 21st May 2004 and that such pledges have been satisfactorily honoured.”

Ogen ang kunuwawiduyowen, metan ngana AusAid, tsimoren ngana earak, metan ngana assistance tsimoren debarin, tsimoren hotel. Without bita imin anea Mr. Harris riring, inan ekeow memak ngane. Deo rene ngago ekeowet imin. Ogen, nuwawet imin me in place et imin ngana bita edogor onuwaiw.

Ang tsiet bed ngana tsimine rat Cabinet ine ngabuna ogiten edu, dogit eken? Dogin mungana personalities. Ang eo eduwa Mr. President, tsimine imin ngana eo arowong ata kamarar ean. Mr. Speaker, anga a eo eduwa memak mungana imin oreita meta, kaia ngea ngea bed dogin aeo miow bwe ngam a patow ine me mwa nan tik move ei in motions bwe anim apologise me mwa nan sack ei o tekei bitune meta amune Minister ngage. Eko won defence, eko won appeal. Ata judge me jury, me ogen anga a eab eduwa, I will not be part of that. Oreit quoquon me ied, eken ngea a ied iow ian ia enim tsimine change, me I am listening to debates ngana oreit meta ine. A eo ied engon beo. Gona bed ita aiqen oa oaro ngana debates ibibogi ei, constructive debates. Otherwise, eken ngana inon? Ekegen? Tei ata politicise ei imin and mud slinging. Ogen anga, I will not be part of that.

Anan ita edegeri imin, tekei bed an amune wanga colleague amen Buada ion oreit pan ngana ang edegeri imin ngana ang ouge bwe there is something at the end of the tunnel, ngea ngea always the objective me anga fail ia anim ied ean mungane edae. Fail ia anim ied ean mungane events oreit meta ine.

Ang eo onani me wiwida eimwin ngana mungana edorer, me onani ngana mungana true facts. Ang tsiet ngana eko emuk me ang eko redon remind ei edogor ngana eko emuk. Meneng Hotel eo pumwe rent. Bwe ada egen ngea emuk won Meneng Hotel? Ada tsimine won cash flow, gona arowonga mungane? Ang oudo oa ang eo oudo. Ang teng tsiet oa ang eo teng tsiet, me dogin bwe ang nim ita rub it in me ang nim ita cause ei nguno bituno question mark ian tubut engame ino aton.

Ang nim eo rattle ei ura me put more fuel on mungana frustrations that they are going through.

Ang nim eko redon epo. Ang eo teng bed allow ei mungana normal government wills, mungana administrative process bwe enim onuwaiw imin. Ang kidoi bed ngana bwe ang oreit miow bed ngana. Ouga oweiyon ngune bitune Parliament. Ogen ang riring imit inon ino ang ouge bwe dogin ata eo trust ei government so therefore ougan ata riring imin ngaga ang eo run ei imin. Bwe inan ed tsinia ang nim run ei it imin? Inan mo an konuaw imin ia amebuna enim metu me run ei it imin? Mungana imin ang set ei in, inan eimwi me mo?

**Mr. Stephen (Ewa/Anetan):** Tubwa, Mr. Speaker.

Ang eo gona rely on past performances. It is an on-going performance ngane mungane imin ang nim aea. Tekei, ata aea wora imin ngage, ngune government tsinia daein questions without notice metan aton. Ouge anga very irresponsible ngane. Ebwak imin ngana ang ied irresponsible. Aura eo meta Parliament, re eo teng meta during questions, public announcements inon ngana ouge ngana ogen wora GE. Ro pan 'white knights' mimin; ro mislead ei House me engame. Ouge anga how do we judge, me how do we go about things? Ang ita megada me allow ei mungana imin ouge bwe enim ita nuwaw?

Ogiten bed odon ian men amea Acting President bita Article 61. it has never been done before ngea bita 61(4), eko Supply. It has never been done before, me where do we stand on that? Ura Cabinet? Ura bed mwid angogen ngarana Constitution? Ang tsiet memak C.J. enim totow won interpretation ean ngarana murana Constitution. Me inan magen bed ngune maramen me nothing. What do we do? Ang ita megada, ang allow ei mungane imin ouge bwe enim happen.

Ang pan directions. Ouge anga ngane mungane bed directions ouge an meta, riringen Constitution, eo teng meta Parliament ean daein questions without notice, announce ei imin towe GE ngana misleading. True ngana past performances ouga woden. Ro orre memak, tsimine memak wodora mungana nuwawen, but the fact remains ngage ang tik iat ekeyeya. Ang acknowledge ei memak ngea ang tik iat ekeyeya.

Ouge anga tsinia responsible ngea government of the day eab ouge bed ata warwar. Eab ouge ata warwar me eab ouge an warwar ngamen bwiet.

Tsinia ita ouge ata nuwaw, ang eo ied directions, ang eiki information ngana concern ei ngamen bwiet, ouge anga eo mo ia ouga, me ang nan ita ouge, ang nan ita warwar anuwaw. Ang nan frustrated. Anga teng bwe government enim megada ine bwo ro nim oneiy mungane, ura nim

be responsible me ro nim tsiet an nuwaw bwieta. Eko magic ian ngane mungane imin ang oreita riring. Ouge anga ngea difference ia wo nim create ei wo nim oquaquiw iat emakur bwe inan nuwaw imin. ngaga. Mr. Rene Harris ngea President ngaga, Mr. Speaker. Ei President ngea, me egeten fortnights ngea? Ngea bita two, wo totu zero ino iruwin still not enough. It is not twenty, Mr. Speaker, it is more than twenty. Performance ngea. Ngea dogin kor an gonogon amebuna Cabinet. Ongaun aura gonogon ngea. Ngea ngea magic. That is their magic. Eken iyu wangara performance, Mr. Speaker?

Ngea amea Mr. President ogiten ei former NPC Chairman. Anga omaran, anga mwitongon bed ngago ei eoningon mwan eken, eoning eken, anga amen golf. It has been sitting there. Just sitting. The shark has been sitting there, mona Bagewa. Egen pumwen ngona? I wonder. Performance bed ngea, Mr. Speaker.

I think their belief is, me aeo tera ngune, abi edae ngune Parliament. They just turn up, sit down, don't say a word me nuwawen. Question time, meta aton me etik metu ngaga magen, okay let us sit down, ang eo badaiy gata.

Eiki anga iyen ngabuna politics Mr. Speaker. Tsimine engameibun mag rora. According to the green book, according to procedures. Wo kenen, exhaustive am riring am makur, wo quoquon bwe wo nim dorer on every issue ngana wo ouge bwe need ei am dorer. Mag rom ia wo egirow, mag rom ia wo karamwen, tsimine kor engameibun eko aura dog, ro play politics. Ro ita karaiyidu edorer me ro ripweda me ro nuwawen.

Anga tsitan amune Member for Buada bwe ogun araiyidu an dorer me megadan bwe enim kaiot an adjournment debate engameibun. That is good, that is very goodm, ngana ngana constructive. Ang kaiot ata ata dorer. Gona ebwak ngana imin apan anga ngana pwer, ogen amie witness me mwa ead aeo dura. Etsiok ken gonogon, etsiok kor gona grasp ei the whole thing but I will work on it, I assure you that, Mr. Speaker. Anan kenen. Eko engame ita yes.

Yes, ebwak engame idiots me wo nan idiot bed eken tsinia wo ita idiot ea token. You are an idiot once, you are a fool the next time, you are a damned ngea gatsiworin me I hope wo nan learn the fourth time around. Anga in the process, ata memak ang kereri.

Ateng ita towe eken bita GE Mr. Speaker. Kaiot an dorer amea Member for Buada, pat ekamarar ion ngea both sides enim quoquon me oepoiy, anga eduwa ngea bita ngana ngago ang

break enim dorer ngabuna engame, anga support ei kor. Me ouge anga eo deri kamadauning if they think they still can dictate ei memak imin, all you have to do is this, all you have to do is that. No, no, no mwa eo orre. No, no, no mwa miwi ngea. No, no, no ma eo ieng ngea. No, no, no mwa eo ouga. Otenamwanin ata dorer? Negotiate ngea? Ura ita pan aura teng me tsinia wo stray even one centimetre either to the left or to the right, ro paten, no, no, no that is not the parameter we are working in. Pweren ia ouga, mwa nim od ean murano side eran bwe eo mo ea gama. Ouge anga enim realistic ngana wora negotiations, eo ita ata derigaiy gata. Let us not just play the game because we are playing politics. Both sides ngana imin.
